MEETING MINUTES	President Gafa called the meeting to order at 6:32 p.m.

DISCUSSION OF	Discussion of Strategic Plan
STRATEGIC PLAN	Dr. Harwood spoke on his direction for the Strategic Planning document beginning with the Mission and Vision Statement; beliefs and values; goals for the district; school improvement plans; and budget plans. He followed that with how each could be executed, assessed, evaluated, analyzed and reported.
	Dr. Harwood's framework for Guiding Practices in setting goals and establishing continuous improvement in the district are: The School System will utilize a data-driven decision making process; the School System will engage in actions, services, and decisions that are customer-oriented; and the School System will maintain and establish collaborative partnerships. He shared the strands for the State of Michigan School Improvement Framework: Teaching for Learning; Leadership; Personnel and Professional Training; School and Community Relations; and Data and Information Management.
	Dr. Harwood concluded with a timeline for when the following reports would be provided to the Board: Superintendent and District Goals, January; Budget Parameters, February; School Improvement Plans, May; Budget Approved, June; Report on Student Progress, July; Report on Staff Evaluation, August; Report on Facilities Planning, September; Report on Learning Environment, October; Report on Staff, Student and Community Survey, November; Mid-year update on School Improvement Plan progress, December.
BUDGET PARAMETERS	Budget Parameters for 2012-13
FOR 2012-13	Dr. Harwood spoke on the anticipated impact on the budget for the 2012-13 school year. He shared with the Board that the central administration has already met with union leadership and the budget impact on existing contracts based on a salary index formula. He also shared that revenues coming in are less than what the expenditures are currently. Dr. Harwood shared his plans to provide the initial proposed Budget Parameters to the Board in February.
PUBLIC COMMENTS	Cathy Abke, Grosse Pointe Woods, shared her thoughts on the work being done on the Strategic Plan. She asked the Board to balance data with a student's ability to learn remembering to keep plans in balance as they proceed with the Strategic Plan.
