SCOPE OF SERVICES

- Collins & Blaha, P.C. is one of the few law firms in Michigan specializing in education and school law. More than 90 percent of the firm's time is devoted to educational clients. For over forty years, Collins & Blaha, P.C. has been committed to aggressive representation of its educational clients. However, aggressive representation does not mean engaging in fruitless and costly litigation. Many times, the most prudent and effective solution to a controversy is early intervention and resolution prior to incurring liability. A detailed description of the components of educational law is provided below.
- 1. <u>PUBLIC SCHOOL LEGISLATION AND LAWS</u>: Collins & Blaha, P.C. was actively involved in the education reforms which were passed in 2011, which included topics such as teacher tenure, revisions to the Revised School Code, public employee's health insurance and amendments to the Public Employment Relations Act. Mr. Collins is regularly called to testify in front of the Michigan Legislature on matters related to both the Revised School Code and the Teachers' Tenure Act.
