I am an elementary parent in GPPSS, who chose to live here because of our wonderful schools-and I am committed to sustaining and building on the standard of excellence set by our district. During the reconfiguration process, I have been privileged to speak extensively with district leaders, teachers, and staff. I've learned greatly from their expertise, and also from hearing the ideas, hopes, and concerns of parents and neighbors throughout the district. This approach—founded in extensive research and collaborative community engagement—is what made our community working group on early education successful, and will be the same approach I bring to service on the Board. Professionally, I have extensive experience leveraging analytic tools and critical thinking methods to tackle hard problems faced by a variety of public and government entities. These includes data-driven methods and human factors approaches to provide a holistic view of an issue. Each of my roles has required me to "get smart quick" on new problem sets, work effectively with diverse collaborators and stakeholders, reach consensus decisions, and explain complex and technical matters to non-expert audiences. Outside my national security and law enforcement experience, I have been active in youth civics and outdoor education through scouting and Model United Nations. A passion for education, fostering trust through communication, careful research and planning, building coalitions—all of these are key competencies for a member of the Board.

Why do you wish to serve on the Board of Education?: Our district remains in a difficult position, stressed by divisions within our community and implementation concerns over reconfiguration—on top of perpetual budgetary/resourcing concerns (driven by Michigan's education funding model), and the other routine business of the Board. It is important to have leaders who will put the work in to help inform and engage all our community members, and set the conditions for administration to effectively run the district. This is especially true when one reflects on the opportunities to expand early education, adult special education, early college, and more, which surfaced during the reconfiguration process. It will be important for the Board to (a) establish clear and actionable strategic direction, and (b) create mechanisms to more effectively leverage community expertise as a

support for our overworked administrators. This isn't an easy time to step into a leadership role in the district, but that's precisely why I feel that I must try to help in any way that I can.

What are your goals for service on the Board of Education?:

My three main goals will be to improve outreach and communication with our community, ensure reconfiguration is executed in an effective and responsible manner, and create an actionable plan to pursue innovation throughout the district.

What do you view as the most important or pressing issue facing the Board of Education in the next 2 years?: During 2020-22, the chief issue facing the Board will be how to responsibly implement reconfiguration without losing sight on this time of change as an opportunity to innovate. Execution for many of these tasks falls to administration but, as our elected representatives, the Board plays a crucial role. It must create the space for administrators to do this work by conducting effective community engagement and providing clear strategic direction. It must undertake related external engagements with other elected officials, such as with our city governments, to help confront interjurisdictional concerns, such as traffic and student safety. And the Board must provide strategic oversight to ensure this work accomplishes its objectives, and stand accountable to the public if it does not.

Letter of Interest:

Dear Vice President Weertz and Superintendent Niehaus,

I seek to join the GPPSS Board of Education because our district remains in a difficult position following reconfiguration, and faces a series of complex challenges and opportunities.

My wife and I are working parents of two young children in the district, and I am passionate about our community and our schools. For more than a year, I have chaired a community working group on early education, which has sought to leverage community expertise and volunteer work to help the district expand our excellent 0-5 program. While that work continues, we have built a strong community consensus, presented the district with well-researched program options, and raised at least \$1 million in startup funds from community donors. I will bring this same approach—founded in research, creative thinking, and community collaboration—to the other issues before our district.

If chosen to serve, my three main goals will be to improve outreach and communication with our community, ensure reconfiguration is executed in an effective and responsible manner, and create an actionable plan to pursue innovation throughout the district.

Beyond early education, many other concerns and opportunities came to light during reconfiguration. Remaining are serious traffic and student safety issues, concerns regarding curriculum and space, continued work toward equity and diversity, and a need to rebuild trust and shared purpose with our community. We also continue to short-staff central administration, and have failed to keep our teacher salaries commensurate with the world-class quality of our program. But that said, over the past several years, the hard work of our Board, administrators, and community also has put the district on sound financial footing, made needed improvements to our curriculum, and expanded opportunities. Community members have elevated impressive ideas to expand fundraising, improve special education, create career training and college credit programs, and more.

Together, we have the ability to confront these challenges and seize these opportunities—and I would be honored to play a role in moving us forward.



The entire team –principal, home teach, therapists, everyone –goes out of their way to come up with new solutions to whatever new challenges our son finds himself in. The results have been far more than my wife and I even prayed for when we first got our diagnosis.

We want Grosse Point to continue to be able to offer this kind of care to all of its students, from nonverbal kids to AP students, and I want to be part of finding solutions that it this level of education continue at Grosse Pointe.

I look forward to discussing my interest further in person.
