GPPSS Pupil Enrollment Projection Study (PEPS) Update

- Background
 - Plante Moran Cresa (PMC) presented the 2022 PEPS report and findings to GPPSS Board of Education on March 14, 2022
 - Highlighted the continuous decline of K-12 enrollment
 - Decrease birth rates
 - Impact of Covid to the Learning Environment
 - Decrease # of housing units and families
 - Board of Education inquired about and requested additional insight relative to the following;
 - Decreased number of housing units by municipality
 - Update peer district comparisons for GPPSS

GPPSS Housing Review

- Review of Housing Units by Municipality
 - PMC reviewed updated housing information from several data reports including U.S. Census Bureau, Nielson-Claritas, ESRI, and SEMGOC specifically to GPPSS boundary.
 - PMC contacted the (6) municipalities within the GPPSS boundary to review and discuss housing trends and data points.

Total Number of Owned Units: 17,370 (81%)**

Total Number of Rental Units: 4,075 (19%)**

GPPSS Housing Review

- ☐ Definition of "Housing Unit"
 - A housing unit is a residential structure (house, apartment, a group of rooms, or a single room) that is occupied by owner or renter (or if vacant, is intended for occupancy) as separate living quarters.
 - Separate living quarters are those in which the occupants live and eat separately from any other persons in the building and which have direct access from the outside of the building or through a common hall.
- ☐ Insight into Housing Units in GPPSS
 - Decrease of approximately 590 units (since 2018)*
 - Initial findings indicate predominately a decrease of multiple rental units into either single rental or transitioned to single occupant "owned" housing unit
- ☐ Breakdown by decrease of housing units by municipality (since 2018)*
