Below are clarifications and answers to vendor questions to date:

Clarifications:

1. Please include the removal of all CATV cabling for Defer and Ferry as part of your cabling demo in Section 3. This has already been completed at the other buildings.
2. There will not need to be a data cable pulled to the panel location at South HS, Parcels and Monteith. Appendix A has been updated to reflect this.
3. For the large area AV alternate, please bid a projector and sound cart for the Middle School, similar to the elementary carts, along with a larger screen.
4. The following items(s) were added to Appendix A:
 - a. Please list all cabling manufacturers that you are certified to install.
 - b. Please provide pricing for both full and half size racks and cabinets.
5. The following vendors were in attendance at the prebid meeting: Amcomm, AMR, CIT, DAT, Lightspeed, Ricoh, Tierney, UTEC, VEC, VSC.

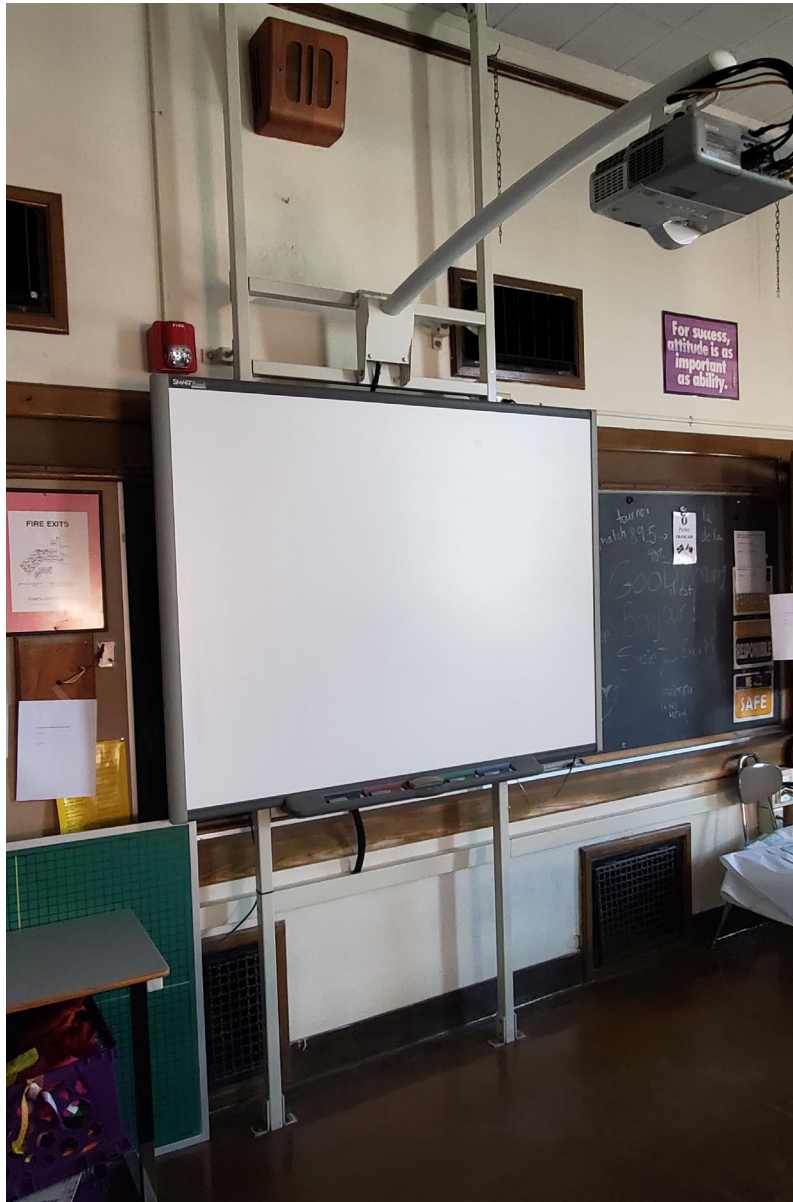
QUESTION	ANSWER
1. Can we just bid on a single section of the RFP?	Yes – you can, however we also encourage you to partner with others for a complete solution.
2. Can you provide a photo of a room that currently has a floor to ceiling mount for AV?	See photos at the end of this addendum.
3. Are there loading docks at each building?	The following building has a loading dock: Parcels MS

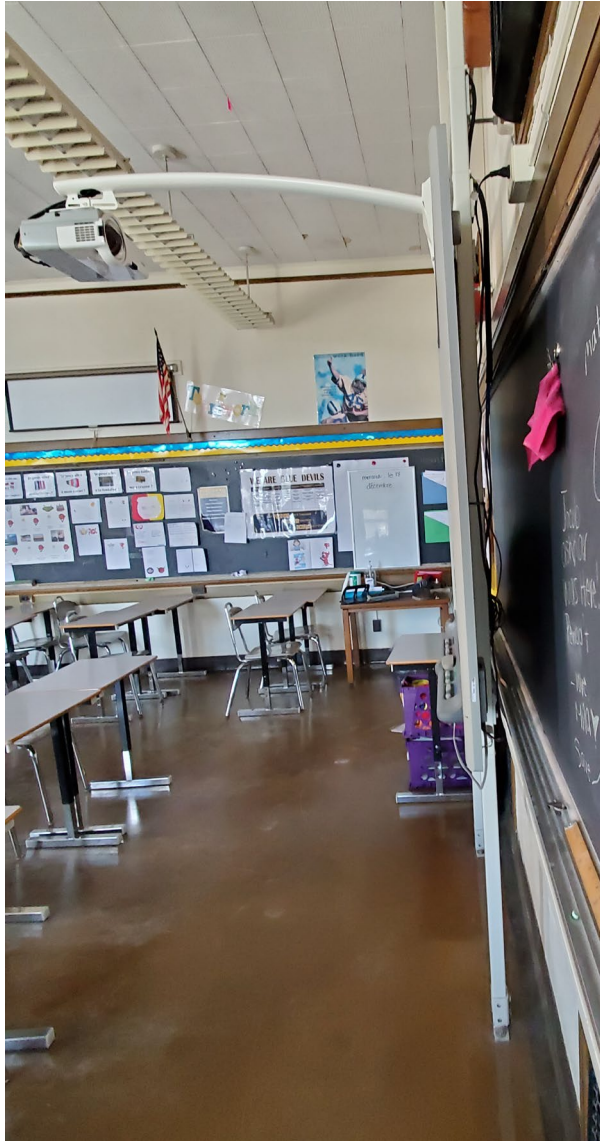

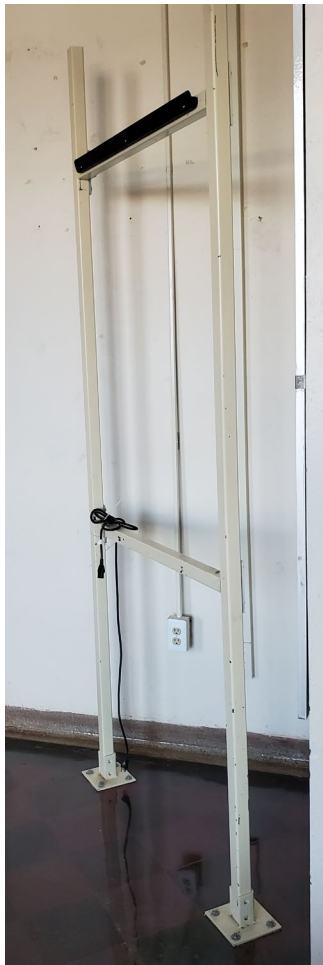
QUESTION	ANSWER
4. Does each building have an elevator capable of moving pallets?	The following buildings have large elevators that can handle pallets: Parcels MS, South HS. Defer, Ferry & Monteith all have elevators and we believe that they can hold pallets, but cannot guarantee that they are large enough.
5. Will the classrooms that don't have dropped ceilings be receiving dropped ceilings as part of construction?	The majority of the classrooms at the elementary schools either have dropped ceilings currently or will have the ceilings replaced as part of construction. We believe that most of the classrooms at South and Parcels will have a dropped ceiling as well, but cannot confirm all. We will ask for a unit cost for raceway to be added in rooms that have hard ceilings.
6. Have the construction bids been awarded yet?	No, bids are due in January and February.
7. Who are the architects and construction managers?	The District is working with French and Ehrsmann architects and Turner Construction
8. Are any additional floor cores required for the structured cabling?	No, we do not anticipate any
9. Are there any locations that require conduit and/or cable molding for the structured cabling?	We do not anticipate any, however we have asked for unit pricing for this, as situations may arise as the implementation progresses.
10. Could you provide any additional detail surrounding the Construction/installation schedule?	At this time, the contracts have not yet been awarded so we do not have final schedules. We would anticipate this to follow a typical summer construction schedule, where we are able to do some of the prep work during the early summer (cabling), but cannot do the install of the equipment and possibly the speakers until August.
11. Can you please confirm or identify the IT closets for each building	See attached prints. Stars have been added to indicate MDF and IDF.

12. Can you provide additional details as to what hours vendors will have access to the buildings while completing the project? Will access be limited or will the awarded vendor be provided with keys/access codes/etc?	<p>The buildings are typically staffed from 7a-3:30p. Vendors should work towards this hours, however the District will generally accommodate the required schedule to accomplish the work. Any overtime or weekend work requires 1 day prior notification to the district. The high school runs two shifts all summer, so those buildings are generally available 7a - 10p. As someone from the district is required to be in the building, the District does not provide keys or badge access to contractors.</p>
