The Board of Education of the Grosse Pointe Public School System, Wayne County, Michigan, will receive sealed bids for District-wide Plumbing Repair & Replacement improvements for a base term of three (3) years with two additional one (1) year extensions possible. Base term will expire on June 30, 2020.

A **pre-bid** meeting will not be conducted for this project.

Sealed bids will be due **Wednesday, April 12, 2017 at 11:00 a.m.** at the Administration Building of the Grosse Pointe Board of Education, 389 St. Clair Ave., Grosse Pointe, MI, 48230, in the Support Services Office at which time and place the bids will be opened and publicly read aloud. The public opening will begin at 11:00 a.m., and will include the reading of several separate indefinite scope / indefinite quantity contracts that are being bid at the same time. The projects to be opened and read on this date include tuckpointing, doors & hardware, wiring & lighting, plumbing repair, environmental, roofing repair, general trades and asphalt paving. There may be a delay in the reading of the specific project that the bidder may be submitting. Results of the unit prices and the apparent lowest responsible bidder(s) will be made available when they are recorded and tabulated based on a sample scenario and quantity.

The School Board will not consider, accept, or open a bid received after the date and time specified for bid submission in this advertisement for bid.

The bids shall be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the bidder and any member of the board of the superintendent of the school district. The board will not accept a bid that does not include this sworn and notarized disclosure statement.

The bids shall be also be accompanied by a sworn and notarized Iran Economic Sanctions Certification. The board will not accept a bid that does not include this sworn and notarized certification.

Grosse Pointe Public School System's Board of Education reserves the right to accept or reject any and all Bid Proposals, either in whole or in part, to waive any informalities or irregularities therein, or to award the contract to other than the contractor(s) submitting the best financial Bid Proposal (low bidder), in its sole and absolute discretion.
